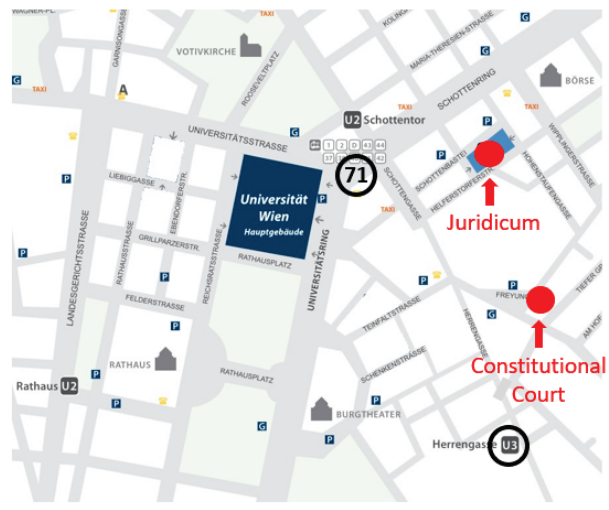

MAPS & PUBLIC TRANSPORT

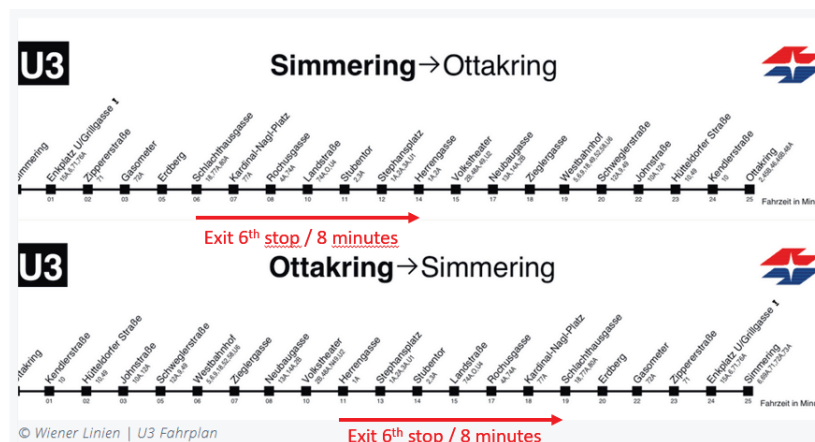


Hotel Gabriel → U3:
3 blocks, ca 700 meters, ca 9 minutes
Alternatively, you could take the bus 74A from
“Petrusgasse” (1½ blocks, ca 200 meters,
ca 3 minutes from Hotel Gabriel) and change to
U3 at “Rochusgasse” (5 stops).

U3 → Juridicum: ca 700 meters, ca 9 minutes
U3 → Constitutional Court: ca 400 meters, ca 5 minutes

Underground Line U3

Schlachthausgasse → Herrengasse → Schlachthausgasse



Total time (Hotel Gabriel → Juridicum) via U3: ca 26 min (ca 1.400 meters walking)

Please note: Regrettably, the tram line 71 (only 5 minutes from Hotel Gabriel and directly going to Vienna University), which has been one of the reasons for choosing this hotel for you, is out of service in July/August 2025 (due to track construction work on Ringstrasse).
