# WHAT IS THE ELSA LAW REVIEW?



The **ELSA Law Review (ELR)** is an annual, student-edited and peer-reviewed law journal published by the European Law Students' Association (ELSA).

The **mission** of the ELR is to create a forum for the analysis and discussion of contemporary legal issues by serving as an avenue for the ELSA network to publish its academic work. It aims to provide law students and young lawyers, as well as the wider legal profession, with a source of critical commentary that is outside the scope of the typical legal curriculum.

The ELSA Law Review **was founded in 1989** and it was published twice per year until 1996. It was re-established in 2015.

## Authors

Once the Call for Submissions is launched, authors are invited to submit their contributions within the submission period. We offer authors the opportunity to showcase their legal perspective, research, and writing skills to an international audience.

## Editorial Board

The Editorial Board, consisting of students and young lawyers from ELSA's Publications Team, carefully reviews all submissions. The Board provides constructive feedback to authors and conducts a pre-selection process, ensuring that each article meets the basic quality, structure, and relevance standards of the ELSA Law Review.

## Academic Board

Legal Professionals and Academics from different institutions in Europe select the best articles that are going to be published in the ELSA law review and provide the selected-to-be-published authors with academic feedback.

## Where to start?

1. Review the submission documents
2. Write your article
3. Submit it through the Form

## What happens after you submit your work?

1. **Shortlisting** of submitted articles
2. **Peer-review** by the Academic Board
3. Review of shortlisted articles by the **Editorial Board**
4. **Publication**
